This is to inform regarding the updated schedule of the most awaited 2<sup>nd</sup> Women's Kabaddi World Cup 2025, which is now to be held at **Dhaka, Bangladesh** from **15<sup>th</sup> to 25<sup>th</sup> November 2025**.

We hereby extend our warm invitation to your respective national team to participate in this prestigious global Tournament.

**Terms and Conditions:**

1. Eligibility Weight: Women: Body Weight - 75 kg or below.
2. Each team may register a maximum of 14 Players, 2 Coaches, 1 Manager and 1 International Technical Official. Total 18 members.
3. The matches will be played on Mats (every player has to wear mat shoes without which no player will be allowed to play).
4. Entry Form should be signed by President/Secretary and should be carried to the venue of Women's Kabaddi World Cup 2025. All the matches will be played under the rules & regulations of IKF.

**Last date of Participation Confirmation:**

Confirmation on your team participation should reach latest by 3<sup>rd</sup> October 2025.

## **Disciplinary Committee:**

1. The Executive Board of IKF will be responsible to exercise disciplinary action against any player/team that contravenes with the rules of the game or acts that bring disrepute or disrupts the spirit and sanctity of the Tournament. Such disciplinary action may include suspension or fine.
2. A team can lodge protest within one hour after completion of the match with a fee of USD 100.

## **Boarding and Lodging/Transportation:**

1. The Organizing Committee at Dhaka shall provide free boarding and lodging to the participating 14 Players, 02 Coaches, 01 Manager and 01 International Technical Official, totally 18 members per team including airport transfers, hotel to venue transfers and transportation for official events.
2. All participating teams and officials will be provided with accommodation in 3-star and 4-star category hotels, located in the close proximity to the competition venue.
3. Accommodation will include full board-Breakfast, Lunch and Dinner and all necessary amenities to ensure comfort and security.

## **Medical Facilities:**

On-site medical teams including doctors and physiotherapist will be available at venue throughout the Tournament.

## **Visa Process:**

All foreign participants and officials will be facilitated with Visa on Arrival at Hazrat Shah Jalal International Airport, Dhaka.

The VISA fees USD 51 per person payable upon arrival and must be borne by the Member country.

Bangladesh Kabaddi Federation will issue Visa on arrival letters to participating member country to support smooth entry procedures.

## **Security and Other provisions:**

Comprehensive security arrangements will be in place in cooperation with Government of People Republic of Bangladesh to ensure the safety of all players, officials and guests. Training facilities, practice venues and Competition courts will be prepared in accordance with international standards.

## General Conditions:

1. Each team should carry two National Flags.
2. National Anthem Audio Clip to be shared in advance through e-mail for the medal ceremonies.
3. Participation of players, coaches and officials will be strictly voluntary and no force will be exerted for anyone to participate.  
It is to be noted that IKF/ Organizing Committee will not be held responsible for any untoward incidents or loss or any other mishaps during the tournament.
4. The IKF/Organizing Committee reserves the right to make necessary changes to the schedule in the best interest of the program and participants.
5. The teams should report an hour before the commencement of the match to the warm up area.
6. Team managers of each team shall submit the name list of the players 30 minutes before the commencement of their match to the Referee in-charge. Every team must report to the call room 15 minutes before the scheduled time of their match.
7. The players should be in proper playing kit including mat shoes as per the rules of the IKF.
8. The matches will be played on Kabaddi Synthetic mat surfaces.
