Terms and Conditions:

- 1. Eligibility Weight: Women: 75 kg and below Body Weight
- 2. Each team may register a maximum of 14 players, 2 coaches, 1 Manager and 1 International Technical Official. Total 18 person.
- 3. The matches will be played on Mats (every player has to wear playing shoes without which no player will be allowed to play)
- 4. Entry Form should be signed by President/Secretary and should be carried to the venue of Women's Kabaddi World Cup 2025. All the matches will be played under the rules & regulations of IKF.

Last date of Entry

1. All confirmations should reach the IKF by email by 10th July 2025.

Disciplinary Committee:

- 1. The Executive Board of IKF will be responsible to meet our disciplinary action against any player/team that contravenes with the rules of the game or acts that bring disrepute or disrupts the spirit and sanctity of the championships. Such disciplinary action may include suspension or fine.
- 2. A team can lodge protest within one hour after completion of the match with a fee of US \$ 100/-
